#### **Report Highlights:**

On December 18, 2020, the State Council Tariff Commission (SCTC) announced its annual tariff adjustment plan that sets tentative import and export tariff rates for selected commodities in the year 2020. Notably, China will tentatively lower the applied most favored nation (MFN) import tariffs for certain pork products, seafood, wood products, dairy products, processed fruit, nuts, and pet food. The tentative tariff rates are applicable to all exporting countries. The SCTC announcement does not affect the retaliatory tariffs on U.S. exports to China. This report includes an unofficial translation of the SCTC notice and the list of the agricultural commodities subject to lower applied MFN tariff rates in 2020.

#### **General Information:**

At the end of each year, the State Council Tariff Commission (SCTC) sets tentative import and export tariff rates for selected commodities to be applied during the following year. At the same time, SCTC also announces China's tariff rate quotas (TRQ) for all products. On December 23, 2019, the Ministry of Finance published on its website a SCTC notice (dated December 18), releasing its tariff adjustment plan for 2020. While tentative tariff arrangements for most agricultural commodities remain unchanged from the previous year, the applied MFN import tariffs for certain pork products, seafood, wood products, dairy products, processed fruit, nuts, pet food, and other food and agricultural products will be lowered in 2020 (see Annex 1). The tentative tariff rates are applicable to all exporting countries. This GAIN report contains an unofficial translation of the SCTC notice, including the food and agricultural products listed in Annex 1 of the announcement and the corresponding applied MFN tariff rates for 2020. The SCTC announcement does not affect the retaliatory tariffs on U.S. exports to China. The forthcoming GAIN report CH2019-0194 outlines the currently enacted retaliatory tariffs against U.S. exports.

#### **Notable Tariff Reductions in 2020:**

The SCTC tariff adjustment plan has lowered import tariffs for frozen hams, shoulders, and cuts of swine (with bone) (HS 02032200) and other frozen meat of swine (HS 02032900) to 8 percent from the current 12 percent. The new tariffs, which will take effect on January 1, 2020, are aimed at encouraging pork imports to fill the gap caused by China's ongoing outbreak of African Swine Fever (ASF). The SCTC plan also cuts the import tariffs for numerous seafood and wood products to accommodate Chinese demand. The import tariffs for orange juice (HS 20091200, HS 20091900) and frozen avocados (HS 08119090) will also be lowered in 2020.

The General Administration of Customs,

In an effort to optimize the trade structure and facilitate high quality economic development, the import tariffs for some commodities will be adjusted as of January 1, 2020 based on relevant provisions of *the Import and Export Tariff Regulation of the People's Republic of China*. The Adjustment Plan Including Tentative Import Tariff Rates in 2020 is printed and delivered to your Administration. Refer to the Appendix for details.

### **Appendix:**

## The Adjustment Plan Including Tentative Import Tariff Rates in 2020

- I- Adjustments on import tariff rates
- 1. Most Favored Nation (MFN) Tariff Rate
  - 1) Tentative import tariff rates will be applied to a total of 859 commodities (not including commodities subject to Tariff Rate Quota) as of January 1, 2020. The tentative import tariffs on 7 IT products will end on July 1, 2020 (see Annex 1).
  - 2) The MFN tariff rates on IT products listed in the annex of Amendment to the Tariff Schedule of the People's Republic of China to the World Trade Organization will be reduced for the fifth time on July 1, 2020 (see Annex 2).

## 2. Tariff Rate Quota (TRQ) Tariff Rate

TRQ management will continue to apply to eight categories of commodities including wheat and the tariff rates will remain unchanged. Of which, a tentative one percent TRQ tariff rate will apply to three fertilizers including urea, compound fertilizer, and diammonium phosphate. A sliding tax will continue to be levied on certain amount of out-quota cotton import (see Annex 3).

- 3. Conventional tariff rates and special preferential tariff rates
- 1) Based on the trade agreements and preferential tariff arrangements signed between China and certain countries or regions, the conventional tariff rates with New Zealand, Peru, Costa Rica, Switzerland, Iceland, Singapore, Australia, South Korea, Chile, Georgia, and Pakistan, who have signed a bilateral trade agreement or Asia-Pacific Trade Agreement with China, will be further reduced as of January 1, 2020. In accordance with the provisions of the bilateral trade agreement between China and Switzerland and the Asia-Pacific Trade Agreement, the conventional tariff rates will be further reduced as of July 1, 2020 (see Annex 5).

When MFN tariff rates are lower or equal to the conventional tariff rates, they shall be implemented in accordance with the provisions of relevant agreements if there are such provisions. If there are no such provisions, the lower rates shall apply.

2) The special preferential tariff rates will continue to be applied to other least developed countries who have established diplomatic relations with China and have completed the process of exchange of letters, with the exception of Equatorial Guinea who will stop enjoying the special preferential tariff rates as of January 1, 2020.

## II - Export tariff rates

Export tariffs will continue to be applied to 107 commodities including ferrochrome with applicable export tariff rates or tentative export tariff rates. The scope of commodities subject to export tariffs and the export tariff rates remain unchanged (see Annex 4).

# III-Implementation time

The above plan will be implemented on January 1, 2020 unless otherwise specified.
