IN CONGRESS, JULY 4, 1776.

The unanimous Declaration of the thirteen united States of America.

When in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them; a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. — That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly by all just and reasonable men, it will be borne, that only in the most extreme and desperate cases, the People should be obliged to alter or abolish their Government; and even then, they should be prepared to assume the responsibility of the new Government.

We have asserted our rights, and justified the most extensive and complete system of non-importation, and have declared our intention to continue it, until our demands are complied with. This year, we hosted Trade Salon Dinners in London and Brussels, featuring senior trade officials, business leaders, and policy experts from both sides of the Atlantic in the same spirit of community that defines tonight's Annual Dinner. In the months to come, we look forward to hosting events during the WTO Public Forum in Geneva, and in Dublin and Brussels later in the fall. As we grow WITA's international presence in Europe, we are laying the foundation for future engagement in Latin America, Asia-Pacific, and Africa, and building on our first India Intensive Trade Seminar, held this spring.

Tonight, we are honored to recognize Senators Maria Cantwell and Todd Young, whose leadership has helped advance America's global competitiveness and expand opportunities for American workers, businesses, and farmers through trade. As trade policy continues to evolve, WITA remains committed to providing a trusted platform where policymakers, business leaders, academics, and trade professionals from around the world can engage in informed, constructive dialogue.

Thank you for being here to celebrate our honorees and the extraordinary global trade community that defines WITA. Thanks as well to our special guests from Signature Theater who will be helping us celebrate this evening.

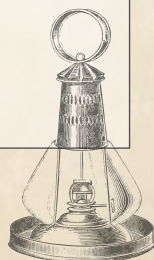

Senator Maria Cantwell

Maria Cantwell currently serves as a United States Senator for the State of Washington. As a respected leader – both in public service and in the private sector – Maria has always embraced the values she first learned growing up in a strong working-class family. With the help of Pell Grants, Maria was the first member of her family to graduate college. Later, a successful businesswoman in Washington's hi-tech industry, she helped build a company that created hundreds of high-paying jobs from the ground up.

Maria was elected to the U.S. Senate in 2000, 2006, 2012, and again in 2018, pledging to honor the hard work, aspirations and faith of the people of Washington state. She is working to create affordable opportunities for consumers, businesses and families, to make our nation more secure today, to foster innovation for tomorrow, and to stand with parents as they educate and care for their children.

Maria gets results. She cut taxes for the middle-class by ensuring that Washington taxpayers can deduct state and local taxes from their federal returns. She fought attempts by the Bush Administration to raise local electricity rates. When bankrupt Enron officials tried to charge Washington ratepayers for millions of dollars in undelivered electricity, Maria led the effort that successfully stopped them. Maria has protected countless jobs in Washington's aerospace industry by cracking down on foreign companies' unfair trade practices and has worked to create still more well-paying jobs through effective investments in new technology and valuable job training. Maria is leading efforts in the Senate to make America more energy independent. She has been a proud advocate for better educational opportunities for our children and less expensive, more accessible health care for our families. Maria continues to build new growth and strong partnerships, insisting on responsibility and making life more affordable for all of Washington's families.

Senator Todd Young



Since joining the Senate in 2017, Todd Young has developed a reputation as a conservative problem solver. On issues like outcompeting the Chinese Communist Party, securing the border, growing the economy, expanding affordable housing options for all Hoosiers, supporting Indiana's veterans, and harnessing the potential of artificial intelligence, Todd has offered conservative solutions to many of the biggest issues facing Hoosier families.

In 2022, the CHIPS and Science Act, his landmark legislation to outcompete China and create more high tech jobs in the Heartland, became law. Vital to America's economic and national security, the law is bringing semiconductor production back to the United States to shore up our supply chain and ensure America is never dependent on China for critical chips.

Todd's path to the Senate went through the United States Marine Corps. After graduating high school, Todd attended the United States Naval Academy, where he played varsity soccer and was elected a class officer. Todd graduated with honors in 1995 and accepted a commission in the U.S. Marine Corps. After training as a rifle platoon commander, Todd served as an intelligence officer, spending time on the U.S. southern border.

After serving a decade in the military, in 2000 Todd was honorably discharged as a Captain. He then spent a year in England, where he wrote a thesis on the economic history of Midwestern agriculture and earned an MA from the School of Advanced Study in London. Upon returning to the United States, he accepted a position at the Heritage Foundation and later worked as a legislative assistant in the U.S. Senate.

In 2003, Todd returned home to Indiana. He worked as a management consultant, advising public and private organizations on how they could implement business practices to provide their constituents and customers with more value, often by investing fewer resources.

In 2010, Todd ran his first campaign for Congress, defeating a strong Democrat incumbent to represent Indiana's 9th Congressional District. He served three terms in the House before running for Senate in 2016.

He serves on the U.S. Senate Committees on Finance; Commerce, Science & Transportation; Small Business and Entrepreneurship; and the Senate Select Committee on Intelligence.
